4. The new owner will retain the responsibility of completing all necessary registration information and must include the word <b>Bully Exchange</b> as the first word in the registered name of the purchased dog when registering the dog.
5. Buyer agrees to provide adequate food, water, shelter, exercise, health care, and socialization. Participation in micro-chipping has been recommended to help insure return to owner in the event of th American Bully becomes lost or stolen.
6. Buyer agrees to provide updates to seller on the health and well-being of this American Bully in the form of email, phone call or written letter in intervals not to exceed 1 year. Pictures of the dog are to be provided to the seller when the dog reaches 1 year of age and at maturity.
7. Buyer agrees to first consult the seller in the event that the purchaser cannot keep the American Bully before selling it or taking it to a shelter, pound, rescue, or any other animal welfare organization for turn

Buyer agrees to first consult the seller in the event that the purchaser cannot keep the American Bully before selling it or taking it to a shelter, pound, rescue, or any other animal welfare organization for turnin with the understanding that such a return does not constitute refund in whole or part. If seller is unable to accept the American Bully the owner will do their best to re-home the American Bully with a new, responsible owner before opting to turn this American Bully into any shelter, pound, rescue or animal welfare organization. If such a home is unable to be found in a reasonable period of time owner will do their best to locate a no-kill rescue or shelter who can accept this American Bully.
- 8. Buyer has been made aware of almost certain euthanasia of this American Bully if it is turned into a shelter, rescue, or other animal welfare organization and of the unfriendly nature many such organizations have in regard to this breed.
- 9. Buyer will notify seller, and all organizations that this American Bully is registered through, prior to selling it to a third party.
- 10. In the interest of bettering the American Bully breed, buyer will notify seller and all registering

organizations of life threatening or disabling disease or defects during the dog's lifetime. Such disease or defects include but are not limited to: cancer, hip dysplasia or other orthopedic issues, heart or other internal organ conditions, cataracts, infertility, birthing difficulty, offspring with birth defects, mental disorders, etc.

- 11. All deposits are non-refundable. The buyer is able to have their deposit transferred to another litter, puppy, or an adult American Bully from the seller in certain extenuating circumstances (medical emergency, death in the family) to be determined by the seller.
- 12. Any knowledge of buyer(s) fighting or cruelty to the purchased American Bully, or being previously convicted of fighting American Bullies or animal cruelty, the purchased animal must be returned to Seller immediately. Buyer must pay all fees of the returning process and/or any additional medical, trauma, and (or) rehabilitation that is required for the American Bully purchased. If buyer can not send the American Bully back to seller, the animal must be giving to the nearest no-kill shelter.
- 13. If payment is 7 days (or more) late from the due date, the seller has the option of placing the puppy back up for sale and holds no obligation for holding the named puppy for the buyer. If the buyer needs more time it will be agreed upon that each day after the due date will be a \$10 holding fee and under no circumstance is the seller obligated to comply with this. No deposits will be returned due to the inability/unwillingness of the buyer to pay the full price.
